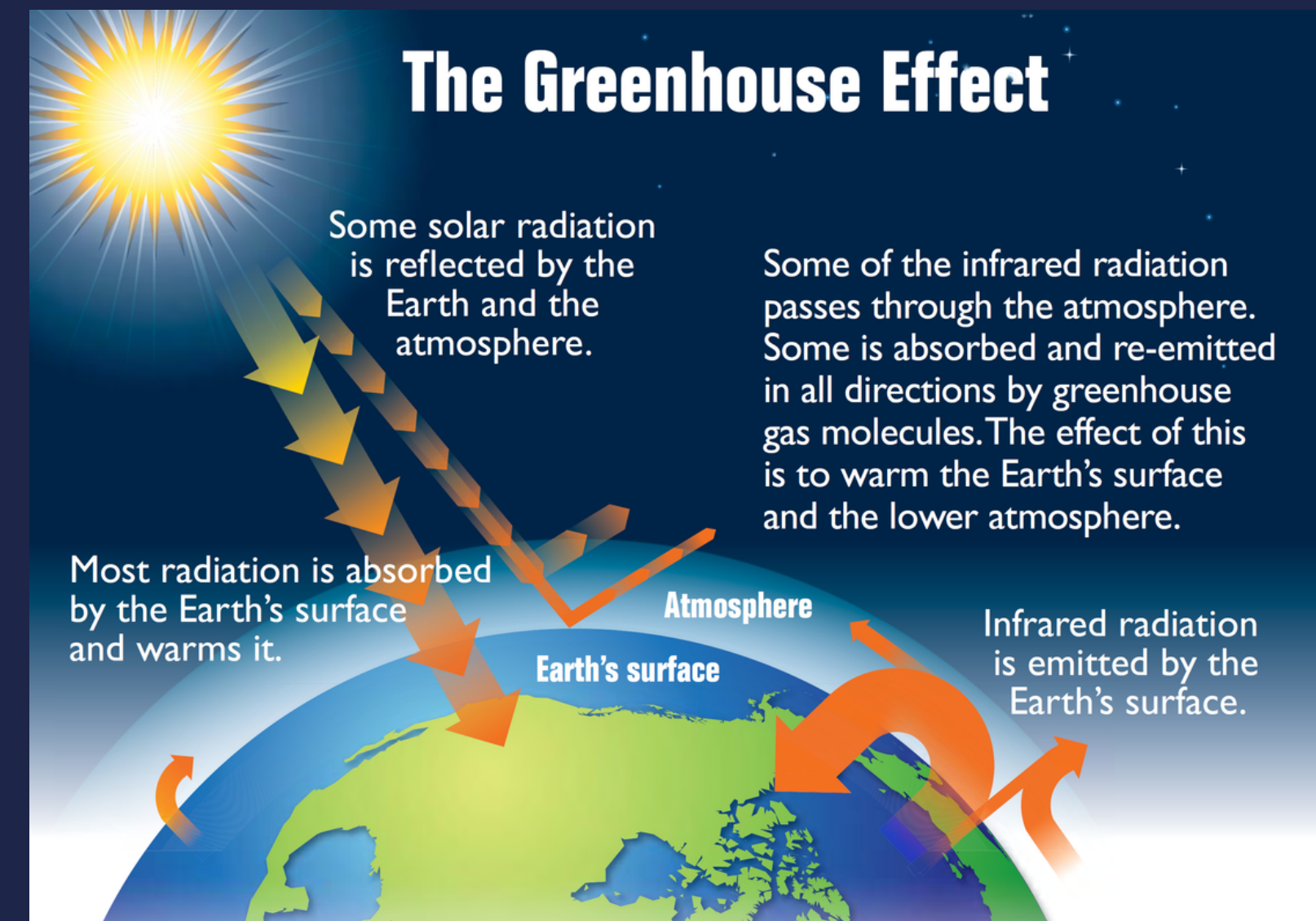

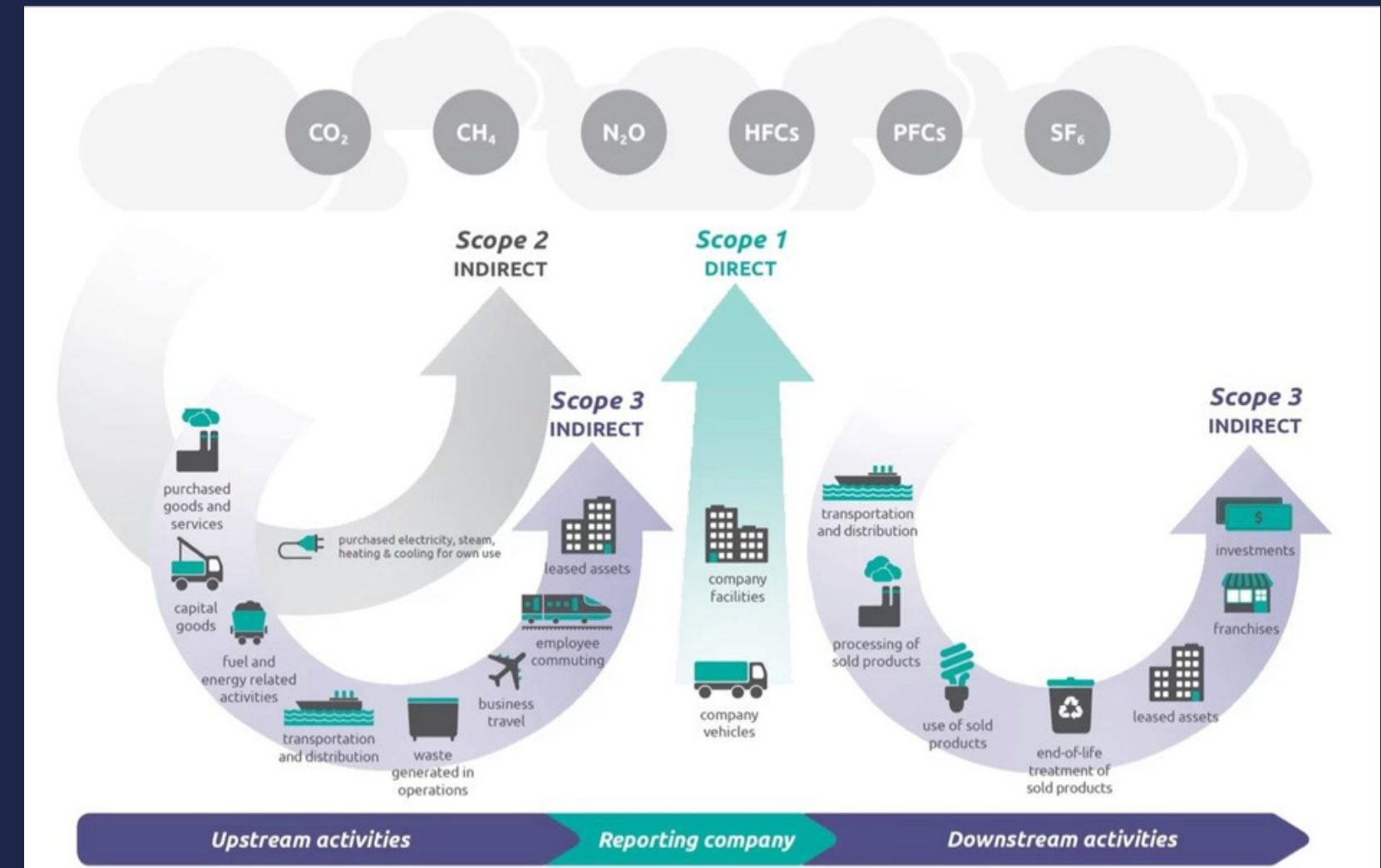

WHAT CARBON FOOTPRINT VERIFICATION SERVICES DO WE OFFER?

We offer verification services for the following GHG-related reporting :

- Company Level Reporting: Corporate Carbon Footprints according to ISO 14064-1, if required in combination with GHG Protocol
- Product Level Reporting: Product Carbon Footprints according to ISO 14067, if required in combination with ISO 14040/44 and/or GHG Protocol
- EPD : The declaration of the life cycle environmental impact of a product





CARBON FOOTPRINT ASSESSMENT ISO14064

Carbon Foot-Print assessment is now a concern for all stakeholders involved in the issue of climate change. It is fundamental for managing greenhouse gases.

It is required by companies that are involved in GHG emissions trading according to international emission mitigation, adaptation and reduction standards.

Verification and validation body is responsible to verify the credibility of the sustainability published reports.

In particular, Carbon foot print assessment refers mostly to cement factories, pulp and paper producing installations, ceramic product factories, lime production installations, mineral oil refineries and also activities that include combustion emissions or airline companies, but the list of related sectors is expanding.

WHY A CARBON FOOTPRINT SHOULD BE VERIFIED

Companies are increasingly being judged based on their sustainable actions by business partners, investors, analysts, the media, and consumers. A sense of responsibility and dedication to climate protection is expected. Companies can use a carbon footprint inventory to determine their climate-relevant emissions. It then serves as a decision-making basis for developing climate protection targets and charting a strategic route.

Is that, however, sufficient?

It will be sufficient only when a Greenhouse Gas (GHG) balance has been independently verified, it becomes genuinely reliable and can be shared in a meaningful way.



BENEFITS OF VERIFICATION OF CARBON FOOTPRINT

The basic benefits of carbon footprint Verification are the following:

- Achieve and demonstrate legal compliance in areas of the world where verification is a legal requirement
- Allow for the company to participate in emission trading schemes
- Identify operational carbon footprint and opportunities for reduction
- Identify opportunities for energy consumption and optimisation of energy efficiency
- Present credible disclosure to stakeholders and investors
- Increase of energy and environmental awareness among personnel
- Demonstrate management commitment and Improvement of corporate image

The goal of the verification is to create reliability and transparency, identify emission drivers and push innovation to reduce greenhouse gas emissions, energy consumption and raw material expenditures.

CARBON FOOTPRINT ASSESSMENT ISO14067:2018

ISO 14067 defines the principles, requirements and guidelines for the quantification of the carbon footprint of products. The aim of ISO 14067 is to quantify GHG emissions associated with the life cycle stages of a product, beginning with resource extraction and raw material sourcing and extending through the production, use and end-of-life phases of the product.



What is Environmental Product Declaration (EPD)?

it is the report card of your products' environmental impact. It reports the environmental impact over the product life cycle. The environmental benefits of a company's products, such as recyclability of packaging, are part of its overall marketing strategy, and companies want to communicate this to their consumers

The EPD methodology is based on the Life Cycle Assessment (LCA) tool that follows ISO series 14040

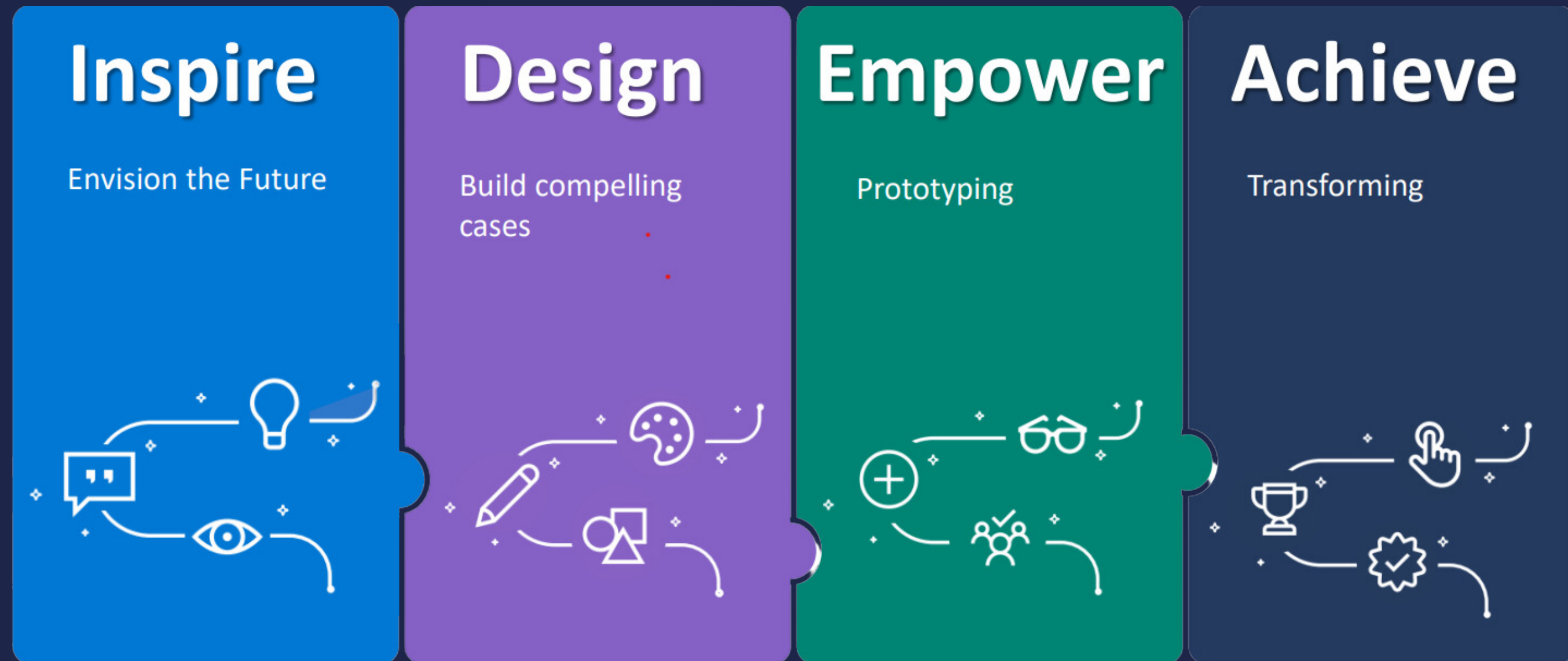
Environmental Product Declaration (EPD) is defined by International Organization for Standardization (ISO) 14025 as a Type III declaration that "quantifies environmental information on the life cycle of a product to enable comparisons between products fulfilling the same function

NES-EUROCERT helps in verifying Life cycle assessment of the product and also in verifying the EPD labels developed as per ISO 14020

EPD Creation Process

1. Identify an existing PCR or create a new one
2. Perform an LCA assessment based on the PCR requirements
3. Develop the EPD to clearly communicate the product's environmental performance
4. Review the LCA and verify the EPD with an independent third-party
