## ISO 14064-1

ISO 14064-1 is an international standard developed by the International Organization for Standardization (ISO) that provides guidance and requirements for quantifying and reporting greenhouse gas (GHG) emissions and removals at the organizational level.



## ISO 14067

ISO 14067 is an international standard that provides principles, requirements, and guidelines for quantifying and reporting the carbon footprint of a product (CFP).

**Who Uses ISO 14067?**

Manufacturers aiming for eco-labeling or carbon declarations. Organizations involved in product sustainability assessments. Brands wanting to make "low-carbon" or "carbon-neutral" product claims.

Entities responding to CDP, ISCC PLUS, or retailers' climate targets.

It means certification of biofuel or bioenergy based on specific sustainability requirements. Certification conforms to the requirements of Renewable Energy Directive (RED II), EU 2018/2001.

It was developed by the Sustainable Apparel Coalition, a non-profit organization founded by a group of fashion companies. The Higg facility environmental module (Higg FEM) is a sustainability assessment tool that standardizes how facilities measure and evaluate their environmental performance.

# PRODUCT CERTIFICATION



## OCS (ORGANIC CONTENT STANDARD)

The OCS applies to any non-food product containing 5-100 % organic material. It addresses the flow of product within and between companies, raw material verification, post-harvest processing, manufacturing, packaging and labelling, storage, handling, and shipping through the seller in the last business-to-business transaction.



## RCS (RECYCLED CLAIM STANDARD)

The Recycled Claim Standard (RCS) is an international, voluntary standard that sets requirements for third-party certification of Recycled input and chain of custody. The Recycled Claim Standard is intended for use with any product that contains at least 5% Recycled Material. Each stage of production is required to be certified from beginning to end in final business to business transaction.



## GOTS (GLOBAL ORGANIC TEXTILE STANDARD)

The Global Organic Textile Standard (GOTS) is the worldwide leading textile processing standard for organic fibres through covering social, chemical and environmental requirements in every stage of processing units. The aim of this standard is to ensure atleast 70% of organic fibre, social, and environmental criteria to provide an assurance to the end of customer.



## GRS (GLOBAL RECYCLED STANDARD)

The GRS is an international, voluntary, full product standard that sets out requirements for third-party certification of recycled content, chain of custody, social and environmental practices and chemical restrictions. The goal of the GRS is to increase use of recycled materials in products and reduce/eliminate the harm caused by its production.
